


# Plan Santé Studies



#### MAIN POLICY EXCLUSIONS

We're fully transparent! You will find all exclusions and other information in our **General Terms and Conditions**.

#### Exclusions relating to assistance and medical expenses

- Relapses relating to illnesses and accidents that occurred prior to the start date of the policy, including chronic illnesses and long-term illnesses.
- Pregnancy, maternity expenses and voluntary termination of pregnancies.
- Vaccinations, comfort care, costs relating to eyewear, contact lenses, prostheses of any kind, check-ups, examinations and routine tests and treatments (e.g. for acne, allergies, back pain, contraception, etc.), preventive and follow-up treatments relating to accidents and illnesses which are not covered.

#### **Exclusions common to all aspects of coverage**

- The taking of drugs, narcotics or similar substances and medications not prescribed by an authorised medical authority, and the consequences of doing so.
- • Mishaps occurring due to the policyholder being inebriated.
- Nervous and mental illness.
- • The practice sports as a professional, amateur racing requiring the use of a motorised craft or a microlight, hang glider, flying wing, paraglider or parachute.

You pay the costs initially and then request reimbursement by providing your records (<u>medical records signed off by a doctor, invoices, proof of payment and European bank details</u>) to AVA through your customer page on AVA.FR, by e-mail to **sinistres@ava.fr** or on the GObyAVA app.



For claims of more than €800, the original invoices and care sheets will be requested, as well as proof of payment.
